Committee Activities during the Year:

- Communicated with student via WSWS Student Section on Facebook. The page now has 44 followers, up from 32 last year. The Facebook page was used to promote the research done by WSWS students, and to promote on-line publications from other institutions like Council for Agricultural Science and Technology (CAST), Department of Agriculture and Food of Western Australia (DAFWA), and Queensland Alliance for Agriculture and Food Innovation (QAAFI). The Facebook webpage increased its outreach in recent years, but engagement with posted information was restricted to certain posts (Appendix)
- Advertised the WSWS Scholarship by contacting via e-mail several professors from different universities within the states included in the society by law section. No response was received, and at this point it is unknown how effective this strategy was in increasing number of applicants to the scholarship.
- Assisted students with questions related to the student scholarship application process.
 No complaints were received, but there were a few questions about extension of deadlines.
- We sent letters or e-mails of solicitation for donations to the Silent Auction from October 2014 through February 2015 to several companies/organizations. Companies solicited include:
