Activities during the year:

Represented the WSWS on the CAST Plant Working Group. Participated in most of the monthly CAST Plant Working Group ZOOM meetings. Discussed and prioritized projects and publications that are in development and identified new topics to be evaluated as projects.

Met regularly with Jill Schroeder, CAST Representative for WSSA, and other Regional Weed Society CAST Representatives John Hinz, CAST Representative for NCWSS, Anthony Witcher, CAST Representative for NEWSS, Lyn Gettys CAST Representative for APMS, and Sharon Clay, CAST Representative for ASA. This has been helpful to us in coordinating and completing our CAST Representative Efforts. Encouraged the Southern Weed Science Society to join CAST as a member society. Participated with the WSSA and Regional Weed Science Societies to put a CAST Poster at the NCWSS, NEWSS the WSSA/SWSS meetings. I will be presenting the CAST Poster at the 2024 WSWS meeting.

Worked with Dr. Jill Schroeder, who is the CAST Plant Working Group Liaison for creating a CAST publication about Invasive Species. I helped Jill and scientists representing WSSA and the North American Invasive Species Management Association (NAISMA). A CAST publication, titled "Preventing the next invasive plant: Opportunities and Challenges" was just completed and a Webinar is scheduled for Thursday, February 29, 2024. The Webinar is free, but you need to register to attend. Congratulations to Jill for completing this.

Worked as CAST Liaison towards a CAST Issue Paper on "Integrated Management of FireAdapted Invasive Plants Responsible for Changing Wildfire Regimes." This was developed based on the WSWS workshop on fire and invasives at the 2022 annual meeting organized by Matt Baur, WIPM Center Director). CAST approved the proposal to be developed into a publication. Matt Baur is the project leader. Several members of the WSWS Invasive Species Committee have volunteered to help write sections for the publication. I am serving as CAST

Liaison on this project. Most authors have written their sections. We are working to get the remaining sections completed for the publication.

CAST Announced Dr. Chris Boomsma as EVP/CEO. There was a Welcome reception for him at the CAST Office in Ames, IA on August 3, 2023. He started in August 2023. Keith Schescke retired in August 2023. I welcomed Dr. Boomsma to the CAST organization. I thanked Keith Schescke for all his leadership, achievements, and efforts.

Participated in the CAST Annual Meeting and Associated Meetings at Texas A&M Hotel and Conference Center, College Station, TX on November 6 – 9, 2023. Dr. David D. Baltensperger, Department Head of Soil & Crop Sciences, Texas A & M, and Past President of CAST hosted the representatives at the CAST Meeting. He also let a Plant Working Group Tour on the first day, I participated in this great tour. There was also a tour for the Animal Science Working Group and the Food Science Working Group. The Plant Science tour included visiting Faculty, Staff and Students in Soil & Crop Sciences at Texas A&M. We were shown field and lab research on cotton breeding, production, precision agriculture, plant phenotyping, genomics, drone research and using robotic monitoring of livestock. We met with the USDA – ARS leaders and researchers at their facility on the Texas A&M campus. It was great for me to visit as they have a program specializing in spray application research and testing. We had great meetings and a reception at the Borlaug Institute on the Texas A&M campus. Several previous CAST EVP/CEO's made presentations about their times at CAST. Keith Scheske was recognized for his leadership and service to CAST. Chris Boomsa laid out his plan for CAST going forward. President Sally Flis, Nutrien Ag Solutions transferred the office of CAST President to J. Alex Thomasson, Department Head Department of Agricultural and Biological Engineering, Mississippi State University. The information, technology and history at this meeting was rich. Focus: This webinar will cover the intersection of pesticide registration and mitigation measures, the role of conservation programs in mitigation pesticide movement, as well as best practices for land management.

February 20, 2024

Title: FIFRA, ESA, and Pesticide Consultation: Understanding and Addressing the Complexities Focus: This webinar will cover the complexities and issues of pesticide use labeling, such as use in different geographies, what is practical for pesticide appliers, and lack of harmonization. Possible solutions to address these complexes will also be discussed.

March 12, 2024

Focus: This essay will examine the relevant provisions of both the ESA and FIFRA, provide an overview of EPA's past attempts to meet its ESA responsibilities, and finally take a look at EPA's most recent policy proposals while comparing them to previous efforts.
