# Monte A. appointed Charlie Hicks as Member-at-Large

### Discussed WSWS Meeting 2016 Issues, Successes, etc.

- Hot water a problem in some areas of the hotel
- Nissen: Reading of obituaries may make the meeting a bit long suggestions to truncate somewhat covered in the newsletter

- Mangold: Avoid scheduling discussion sessions on Thursday morning makes attendance tough for some folks.
  - Discussion sessions on the same day also difficult
  - Papers and posters all accepted none culled out
  - Pres Elect responsible for organization of papers student contest needs put first, and other topic related paper placed around them
  - Chairs could assist in some sections?
- Mangold: Discussion sessions could be fruitless?
  - Report does go into proceedings
  - Possibly get all historical topics per section in one spot (save a few clicks)
  - Possibly get write-up into IPSM or other journal
  - Put into quarterly newsletters
    - Chairs should decide what topics should go into manuscripts or other venues
    - Also responsible to bring hot issues to board
- Jha: pdf versions of presentations had some issues in loading for sections
  - Make sure that everything works on the presentations on the chair's computer
  - Responsibility of the Chair's
- Marty Shraer: projection adjustment poor may need better projectors??
  - Chairs are responsible for their own equipment
  - Hotels will charge 450-500 \$ per day per room
  - Find out what the format will be ahead of time (size of screen)
    - Phil ask about 30 days out to get most up to date information

# **Old Business**

- Science Policy Committee Assignment no action items at meeting
- The two members are appointed, no membership action required
- Kirk will contact Lee and Don to find out how many members we can have on list.... We can have more than 2 members
- Student Organization for Memorandum of Understanding for Elena Sanchez Award
  - Students voted to have wording that the award will be given to 2 graduate students and 1 undergraduate student winner
  - Board Moved and Seconded by Prashant Jha
  - Vote passed unanimously
  - Discussion
    - Nissen brief description of who Elena Sanchez was when we announce the award winners
- Student Contest Rep
  - Eric Patterson from CSU sit on student paper judging committee

- McDonald poster contest complaint about not seeing judges board commented that many times the judges don't address the contestant directly but they are there.
- Tara Burke, student at BOD meeting expressed interest in the Herbicide Resistance Committee
  - Other students should contact Kirk about membership on committees and involvement
- Site Selection Committee
  - Site needs to be selected prior to summer board meeting
  - Phil will be following up on Denver hotels
    - Look at hotels in Reno, but will have to meet earlier
    - Charlie and committee will finalize decision and send out for electronic vote
    - Vast majority of breakfast attendees still expressed interest in Denver regardless of price
    - Look at Anaheim to check WAPSM group room
- Stephen Colbert Finance Committee
  - $\circ$  2 CDs come due in Oct 2016 can ladder CDs
  - o Will increase 1.45% currently in 2016 if rolled over
  - Every year we would have \$20,000 annually in October
  - Is it aggressive enough
  - We have investment account \$186,000 available
    - Declined ~\$17,000 over last fiscal year (averaging 4% over long term)
  - Board recommendation: move some money out of money market and place in a ladder CD (5 years 20,000/year)
    - Stephen Colbert motioned
    - Dirk Baker 2<sup>nd</sup>
    - Call for vote passed unanimously

## New Business

- CEUs
  - Request to have more opportunities from membership
  - Difficult due to state requirements and one-day vs. week differences
  - Board recommended having interested individuals champion the process if they are interested.
    - MT is now requiring quite a bit full day to get credit
    - This year we have ID and WA (championed by individuals)
    - If a member wants them, they should submit request CEU credit to respective state
- Student question and contest question (students misunderstood this year)
  - $\circ$   $\,$  Move form to 1 question about contest and that's it
- Resistant Plants request for workshops
  - More information from Jill on that
  - Kirk is following up:
    - Want grass roots workshop discussions to be prepared for 2017 Summit for D.C. – very early organization on it – want specific examples of successes, failures, learnings

• They want national advisor and discussion leader to ensure continuity
