Click on the Publications tab at the top of the WSWS website to find instructions on preparing and submitting your summaries.

The WSWS Awards Committee, chaired by Carol Mallory-Smith, recently selected the student recipients of the WSWS Student Scholarships. These scholarships help students cover the costs associated with attending the annual meeting. Only three scholarships are given each year. This year's winners are: Kelli Belmont from the University of Idaho, Vipan Kumar from Montana State University, and Breanne Tideman from the University of Alberta. Congratulations to these scholarship winners and thank you to all of the student scholarship applicants! With students like these, the future of weed science is indeed bright.

Joe Yenish is working with his program committee to put together a great program for the annual meeting. One big change we are going to try this year is conducting a symposium on Monday, prior to the start of the annual meeting. Report from the President by Drew Lyon

Portland is Ready for You, Are You Ready for Portland?

If you don't already have it on your calendar, the 2015 WSWS Annual Meeting is scheduled for March 9 through 12, 2015 at the Hilton Portland & Executive Tower in Portland, OR. Title submissions are due the Monday following Thanksgiving, December 1, 2014, for the 2015 annual meeting. The deadline for submitting the abstract and all other abstract information is March 2, 2015. Slide presentations must be submitted by March 4, 2015. When submitting a poster or presentation, please follow the instructions described in the Papers & Posters tab found under the Annual Meeting tab at the WSWS website. Actual submissions are done on the WSSA website at www.wssaabstracts.com. With December 1 being the Monday following Thanksgiving, it will be good idea to mark that date on your calendar so that you can contact any potential co-authors and collaborators first thing Monday to finalize and submit that poster or paper title.

A special symposium is being put together by Dr. Bill Cobb, "Using Various Laboratory Tests and Techniques to Aid in the Diagnosis of Suspected Herbicide Problems." A change for this year is that the Symposium will be held on Monday morning and afternoon preceding the opening of the WSWS Annual Meeting. Please remember that when making travel plans and hotel reservations in preparations for the annual meeting and symposium attendance. A partial intent in holding the symposium prior to the beginning of the annual meeting is to attract a good number of crop consultants from the region, convince them to stick around for the rest of our meeting and, possibly become active members of our society.

Following the symposium, the meeting will kick-off Monday night with the Welcome and Retirees Reception. During the General Session the following morning, we will hear from WSWS President, Drew Lyon, and Science Policy Director, Lee Van Wychen. Filling out the General Session Agenda are a presentation on the development of the Pacific Northwest Wine industry by Dr. Joan Davenport of Washington State University at Prosser and a presentation by Brett Chilcott of AgEagle, on using robotic aircraft (drones) within agriculture and other forms of land management. In additional to the general session presentation, we've invited local representatives of AgEagle to the meeting for one-on-one discussions. Ed Davis, Research Section Chair, and Kirk Howatt, Education and Regulatory Section Chair are busy organizing their sessions. Ed and his Project Chairs are planning thought-provoking discussions in Range and Natural Areas, Horticultural Crops, Agronomic Crops, Teaching and Technology Transfer, and Basic Biology and Ecology. These discussion sessions are a unique feature of our annual meetings and you will want to make sure you participate in as many of them as you can.

Begin your plans to attend and participate in the WSWS annual meeting by registering early and making room reservations at the Hilton Portland & Executive Tower for March 9-12, 2015, or plan on coming a day or two early or stay a few extra days. For those planning to fly, flights can be booked into Portland International Airport (PDX). There are many modes of transportation to the hotel from the airport including; limousines, the Super Shuttle, rental cars, taxis, and the MAX light rail system. Reported prices for these transportation options vary from \$2.50 to \$50. However, please look into the various options to see what will work best for you. If driving, please see the hotel website for directions and note valet parking is listed as \$35/day with no on-site option for self-parking. Be warned parking options are limited in the vicinity of the hotel.

We continue to ask WSWS members to consider submitting symposium proposals for future meetings in Albuquerque in 2016 or Coeur d'Alene in 2017. Members are encouraged to creatively design and plan symposia on current or regionally relevant topics. Refer to the spring 2014 issue of the WSWS Newsletter for instructions to submit symposium proposals.

Whether or not you intend to arrive early for the symposium, it might be a good idea to come in early to enjoy the sights, sounds, and activities in the greater Portland area including the Willamette Valley, the Columbia Gorge, and Mt. Hood.

Notes from the Local Arrangements Committee - by Daniel Curtis

Time to think about Portland! Weather in March is variable, last year 50's and 60's for the highs and 30's and 40's for the lows. We can get rain in March so it's good to be prepared. It can also be very nice – we can hope!

Transportation options to the Hilton Hotel and Executive Tower from the Portland airport (PDX):

Max light rail – cost \$2.50 – runs to Pioneer Square which is about a block from the hotel. Travel time is about 40 minutes. First train of the day arrives at PDX at 4:45 AM and last train leaves PDX at 11:50 PM. http://www.trimet.org/schedules/maxredline.htm

Shuttles are available from the airport to the hotel. The **Downtown Airport Express by Blue Star** runs every 30 minutes and costs \$14 one-way and \$24 round-trip to downtown and Lloyd Center/Convention Center hotels and the downtown Hilton.

When leaving the airport, you can find the Downtown Airport Express and other hotel shuttle buses on the terminal's lower roadway (outside of baggage claim) on the far side of Island #2, closer to the parking garage.

The average taxi fare from the airport to downtown is approximately \$40 before gratuity. **Radio Cab** offers a discount with **coupons available on their website**. The one-way trip takes 20-40 minutes. You can find taxis waiting in the center section of the airport terminal's lower roadway outside of baggage claim; to get back to the airport from the city center, you can order a cab through the city's main operators or from a hotel with a dedicated taxi stand.

Parking options for those driving:

Parking is predominately available only in parking garages. Most have size restrictions – especially for height (such as a 6' 8" max) and length so be sure to check first if you have a large vehicle. The information the Hilton provided is below.

Visit the Columbia Gorge. This would probably require a car – but tours are available. Gorge hiking favorites are Eagle Creek trail near Bonneville dam, Multnomah Falls, and Twin Tunnels at Mosier are some great ones. Other gorge trips include visiting waterfalls, researching Lewis and Clark's trip down the Columbia, checking out the old Columbia River Highway including Vista Point are some great ideas. Bonneville dam is also an interesting place to visit. Skiing at Mount Hood should also be available at Timberline and Mt. Hood Meadows Ski Areas. Touring area wineries is very popular. Many wineries are in the area both in the Willamette Valley and in the Columbia Gorge.

Great hiking is available close to downtown Portland in Forest Park. Also there is the Japanese Gardens, Hoyt Arboretum, and the International Rose Test Garden. Links can be found at http://www.travelportland.com/.

The Western Invasive Weed Short Course (WIWSC) is returning to Sylvan Dale Guest Ranch and is scheduled for April 20-23, 2015. The WIWSC is an intensive study of current technologies and best management practices associated with noxious and invasive weeds in the western United States. Participants gain up-to-date knowledge specific to invasive weed management with interactive sessions that include:

- Classroom lecture
- Hands-on demonstration
- Field plots
- Facilitated discussion
- Live weed and herbicide symptomology specimens
- Small group projects
- Educational games
- Time for individual interaction with instructors

The continued partnership with Sylvan Dale Guest Ranch allows us to provide some unique training opportunities. One of the truly unique features of the Short Course is the ability to have a long-term restoration plot. Sylvan Dale has worked with us to establish a fenced site where we have been able to demonstrate weed management combined with native grass establishment. The plots were designed in a way that allows the course participants to see the progression of control and restoration over a three-year period. A twilight weed walk is great way to see the ranch and start learning some weeds.

The Organizing Committee builds the final agenda based on a pre-course survey of the registered participants to assess specific areas of participant interest. The precourse survey will not be sent to participants until they have completed the registration process.

WIWSC is designed to benefit both those new to invasive plant management and experienced professionals seeking a comprehensive update in western invasive weeds and their management.
