### **Activities during the year:**

Since the committee has been officially disbanded, the activity this year was solely by the former chair of the committee.

### Background:

At the time that Arnold wrote the first history of WSWS he did not add photos of the Board of Directors to his book. He did add photos of the Fellows when they were available. Our committee was able to add photos of the Board of Directors and Fellows for most years in the updated WSWS History 1938-2021.

Prior to 1993, Jack Schlesselman took photos of the Board of Directors, Fellows and winners of the student contests for the newsletter, but they were, of course, with cameras that needed to have the negatives developed, i.e. hard copies were made. When Jack retired, he passed along a box of photos and some negatives to Phil Banks for safekeeping. When the WSWS History committee worked on updating the history of the society Phil sent the box to me. I scanned the photos of the Board and Fellows (from 1979 – 1992). The box with the originals and digitized copies are now with Eric Gustafson for safe keeping.

### Request:

I am proposing that the scanned photos be edited to the same format as those we used in the updated history and either placed on the WSWS website separately or added as an addendum to the WSWS History 1993-2021.

Kai Umeda has agreed to help me go through the photos and identify the Board members and their positions using the same format in the updated history.

The photos can be a bit confusing because the photo of the Board was taken at the end of the annual meeting which means that photos identified as the Board say in 1993 was actually the Board for the 1993 -1994 year which was responsible for the 1994 annual meeting. It will take going back through the lists in the updated history, Proceedings, and maybe minutes of meetings to identify the correct year of the annual meeting that the Board members in the photo were responsible for, the individuals, and the positions

that they held. Since Kai and I understand the issues and we might know many of the individuals in the photos I thought it best if we took the responsibility for this task rather than assign it to other volunteer(s).

New Item:

I had a few new copies printed of version 2 with the Student History included. I gave copies Tom Whitson and Celestine Duncan (an original hard copy was already given to Wanda Graves, each of the committee members, and a few others).

Plus, I have a hard copy to give to the Student Liaison for it to be passed along to the future Student Liaisons along with the dandelion digger plaque. Two copies are also being donated by me to the 2024 Student Raffle.

Questions for the Board:

- 1- Will the Board approve of this task by Kai and me?
- 2- Can these photos be archived on the WSWS website either separately with the other history items and/or can they be added as an addendum to the WSWS History 1938-2021?
- 3- Has the Board discussed what position in the Board leadership or committee will be responsible for any changes to the on-line WSWS History 1938-2021 so that it can be added to the Operating Procedures?
